# GENERAL TERMS AND CONDITIONS ARTBOX.PROJECT Palma 3.0

## 1. REGISTRATION

- 1.1 All artists, regardless of nationality, are eligible to apply. There is no age restriction.
- 1.2 The size of the artwork is freely selectable.
- 1.3 The artwork submitted must be the work of the artist, who must hold all copyrights to it.
- 1.4 All art forms and techniques are permitted.
- 1.5 No pornographic, racist or ethically unacceptable works will be accepted. The decision on whether a work of art is accepted lies solely with ARTBOX.PROJECTS. If an unacceptable work is not accepted, the participation fee will be refunded.
- 1.6 Each artist may submit as many works of art as they wish. A form must be completed for each work of art and the participation fee of EUR 47 must be paid. The registration deadline is 15 October 2025.

## 2. SERVICES FOR PARTICIPANTS

- 2.1 Each registered artwork for which the participation fee has been paid will be displayed digitally on a 55" screen during ARTBOX.PROJECT Palma 3.0 at the Casa del Arte in Palma de Mallorca (8-19 December 2025).
- 2.2 From all registered artworks, the jury will additionally select 10 finalists and 10 semi-finalists. The winners will be notified by email on 21 October 2025.
- 2.3 The original artworks of the 10 finalists will be exhibited physically; all works (including those of the semi-finalists) will be shown digitally.
- 2.4 Each work will be labelled with the name of the artist, the title of the work and a personal QR code.
- 2.5 The 20 finalists and semi-finalists will receive an exclusive week at the Open Atelier at Casa del Arte in Palma de Mallorca. The date will be agreed individually.
- 2.6 All participants are free to decide whether they wish to offer their artwork for sale.

ARTBOX.GROUPS GmbH does not take any commission on sales.

- 2.7 Each participating artist will receive a personal certificate of participation.
- 2.8 Each participating artist will receive a picture of his or her artwork as it was shown on the screen.

2.9 Cancellation, termination, postponement or modification of the exhibition: The management is entitled to cancel, terminate or modify an exhibition for good cause. In this case, there is no entitlement to fulfilment or reimbursement of the participation fee.

## 3. SALE OF ARTWORKS

3.1 All participants are free to decide whether or not to release their registered artworks for sale. The ARTBOX.PROJECTS team will actively promote sales. The entire sale amount goes to the artist, with no commission for ARTBOX.PROJECTS.

#### 4. LEGAL

- 4.1 By registering, the artist accepts these terms and conditions.
- 4.2 By registering, the artist declares that they own the copyright to the submitted work.
- 4.3 The copyright remains with the artist at all times. ARTBOX.PROJECTS reserves the right to publish the artworks on its website, social media and print media.
- 4.4 In the event of discrepancies between translations, the German version shall prevail.
- 4.5 Should individual provisions of these terms and conditions be invalid, the validity of the remaining provisions shall remain unaffected.
- 4.6 The place of jurisdiction is the registered office of ARTBOX.PROJECTS by ARTBOX.GROUPS GmbH in 6300 Zug, Switzerland.
